I submit that, the District Educational Officer,
Visakhapatnam in the reference cited, has submitted proposals
for the issue of "No Objection Certificate" for affiliation
to C.B.S.E., New Delhi in respect of Adarsha School, Visakha-
patnam. The School is run by the Adarsha Educational Society,
Visakhapatnam.

The details of the report regarding accommodation, Staff
and other infrastructure provided by the management and fee
paid are as follows:-

1) Registration of the Society:

Adarsha School is run by the Adarsha Education Society,
Visakhapatnam, registered under the Societies Registration
Act, XXI of 1860 with registration No.223 of 1995 (copies
enclosed).

2) Accommodation:

Adequate accommodation with 22 class rooms with separate
rooms for Library, Laboratory, S.U.P.W., Audio-Visual activi
room and Staff room etc. (Plan enclosed).

3) Play grounds:

The school is having 5 acres play area with boundary
walls.

4) Ownership of School premises:

The school is located in a spacious premises taken on
20 years lease from (VUDA) (copies enclosed).

5) Library books:

There are 595 books in the Library. It is reported
that some more references may be added (List of books enclosed)

6) Furniture:

The school is having adequate furniture and office equip-
ments. All the classes have black boards, tables and chairs.
(List enclosed).

7) Laboratory:

The school has well equipped Science Laboratory .
(List enclosed) .

8) Sanitary Condition:

The school is having good drinking water facility clean
Urinals and Toilets for children and Staff (Certificate
enclosed).

9) Recognition by the State Government:

The School is following State syllabus for classes I to V and has adopted 3 - Language formula. There is State Government recognition for classes I to V for Primary Section (Order copy enclosed).

10) Staff:

Adequate qualified staff has been appointed. As per the acquittance Roll for the month of May 1995, the management appointed (6) teachers including Principal, (1) L.D.C. and (1) Peon. As per the Staff list the management appointed another (8) teachers, (1) P.E.T., and (1) Aaya in the month of June 1995. As per the acquittance the teachers are being paid scale of Pay with allowances (copies enclosed).

11) Financial condition:

The financial condition of the school is sound. However, it is reported that the school is functioning from the academic year 1995-96.

12) School management:

Management of school is excellent and all the required record are being maintained.

13) Collection of Fee:

The tuition fee and special fee for classes I to III is being collected at the rate of Rs.2100/- per annum per student excluding Annual charges at the rate of Rs.75/- and admission exam charges at the rate of Rs. 1000/- . Rupees 2400/- for classes IV to VII is being collected towards tuition fees and special fees per student per annum.

14) Strength particulars:
